As the only national organization advocating for improved educational opportunities for Native students, the National Indian Education Association (NIEA) supports and builds partnerships between Native and allied stakeholders that provide opportunities for Native students to thrive in the classroom and beyond. 



State Native Education Legislation

1988

The OK legislature adopts the Indian Education Act, which addressed the needs of Native students.

2010

Lawmakers create the Oklahoma Advisory Council on Indian Education to advise the OSDOE.

2014

OSDOE introduces the Oklahoma Indian Education Resource to guide lesson plans about tribal history.

2014

Oklahoma City Schools prohibit land run reenactments as part of the state history curriculum.

2016

Oklahoma begins to create state plans to implement the Every Student Succeeds Act.

2023

Senate bill 429 became law and override the governors veto. The bill will protect students to wear tribal regalia during official graduation ceremonies.
