### Report Summary

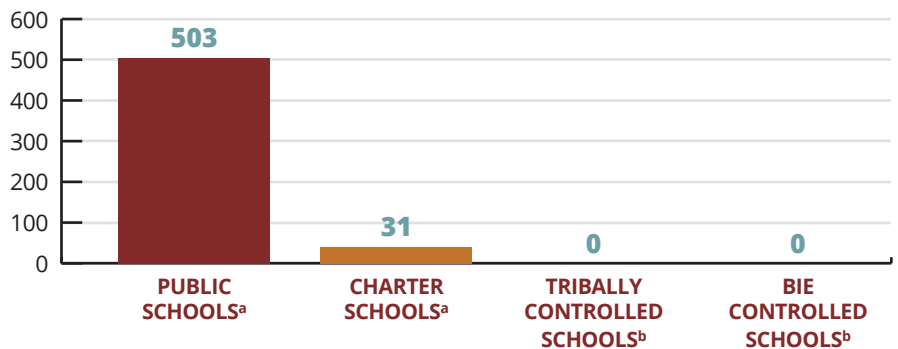
The Every Student Succeeds Act (ESSA) provides tribes and states an important opportunity to advance tribal sovereignty and create positive and inclusive learning environments for Native students. Schools and Native communities must collaborate to ensure students are college, career, and community ready. As the only national organization advocating for improved educational opportunities for Native students, the National Indian Education Association (NIEA) supports and builds partnerships between Native and allied stakeholders that provide opportunities for Native students to thrive in the classroom and beyond. This state profile is available to NIEA membership, tribal leadership, educators, and allies to provide important information and highlight available resources that may be of assistance in advocacy work.

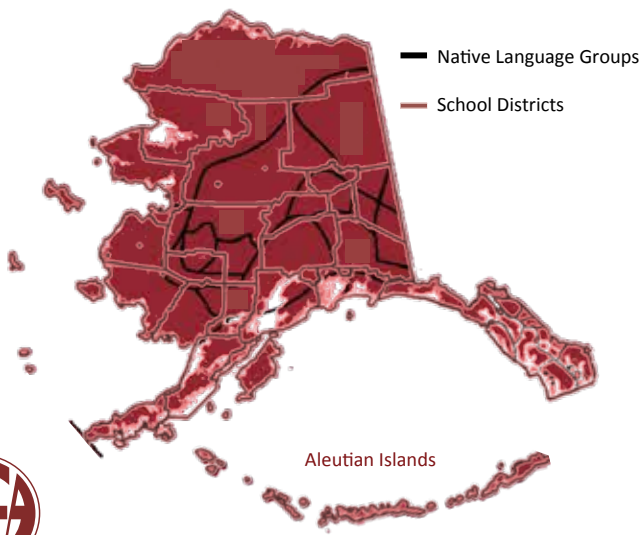

### Federally Recognized Tribes

There are 229 federally recognized tribes within Alaska that speak 22 different languages.

In 1971, the United States Congress created the Alaska Native Claims Settlement Act (ANCSA) of 1971, which divided tribes within Alaska into 12 regions and created regional corporations. In addition, ANCSA established a thirteenth corporation for Alaska Natives who live outside of the state.



# Alaska Native Education Legislation

1972

The Alaska Bilingual Language Education Act establishes Native language and culture in Alaska schools.

1972

The Alaska Native Language Center is established at the University of Alaska to revitalize Native languages.

1976

*Tobeluk v. Lind* affirmed the right for Alaska Native students to pursue high school education in their own communities.

2001

Millennium Agreement states that the Alaska will consult with recognized tribal nations on policy issues in Alaska.

2016

Alaska begins to develop draft state plans to implement the Every Student Succeeds Act.

2022

Alaska opens applications to the Alaska Native Education Program to meet the unique needs of Alaska Native students.
